2025 Sees Digital Accessibility Lawsuits Spike

So far in 2025, plaintiffs have filed 2,019 lawsuits. At the current pace, website accessibility lawsuits are projected to increase by nearly 20% over 2024's total.

This spike follows a familiar pattern: when federal enforcement slows, private plaintiffs step in. What's notable this year is the growing shift toward state-level filings, especially in New York, where courts often offer more favorable conditions for applying the ADA to websites.

This shift in strategy is helping drive the overall rise in digital accessibility lawsuits.

New York Leads, Florida Surges in Website Accessibility Lawsuits

New York continues to lead in the total number of lawsuit filings; however, most plaintiffs are opting to file their cases in state instead of federal courts.

At the same time, Florida is re-establishing itself as a key jurisdiction and is currently the most active state for federal lawsuits.



Defense Rankings Shift: New Plaintiff Leaders Emerge



In 2025, Dentons reclaimed the top position, while Stein & Nieporent LLP and other firms in the top ten remain consistent players on the defense side, only shifting in their rankings. Conversely, in recent years, new leaders have emerged on the plaintiff side as legal activity at the state level expands.

Most website accessibility lawsuits target companies that fall under the ADA's definition of places of public accommodation.

Plaintiffs argue that websites act as digital gateways to the goods and services and so should be required to meet the same accessibility standards.





Lawsuits against large companies are steadily increasing. In the first half of 2025, 36% of sued companies had annual revenue exceeding \$25 million, up from 33% in 2024.

This shift suggests that plaintiffs are focusing on companies with more resources to settle lawsuits. Smaller companies are still targeted but account for a smaller share of lawsuits than in past years.

The more popular a site is, the more likely it is to receive one or multiple lawsuits. Accessibility widgets haven't slowed the rise in digital accessibility lawsuits. More plaintiffs are filing lawsuits against companies that already use these tools. This trend shows that widgets often fail to fix the core accessibility issues that plaintiffs and law firms cite.

Many tools don't correct code-level problems and sometimes create new barriers for people who use screen readers. Widgets often add control panels or overlays that interrupt screen reader navigation, making websites more complicated to use for the people they aim to support.
